Casing/Cement Program: Additional Comments

Yates Petroleum Corporation proposes to drill/test the Precambrian and intermediate formations. Approximately 900' of surface casing will be set/cemented to shut off gravel and cavings. The 8.625" intermediate casing will only be set if lost circulation is encountered. If commercial, production casing will be run/cemented; will perforate/stimulate as needed for production. MUD PROGRAM: 0-900' - FW Gel/Paper/LCM; 900' - 1650' Cut Brine; 1650'-3500 Brine; 3500'- 5405' Starch/Salt Gel/4-6% KCL. BOPE PROGRAM: A 2000# BOPE will be installed on the 8 5/8" casing and tested daily.
