Mack Energy proposes to drill to a 17 1/2 hole to 350 run 13 3/8 casing and cement. Drill a 12 1/4 hole to 2550 using the Lea County Alternative run 8 5/8 casing and cement. Drill to 4400 test San Andres Zone, run 5 1/2 casing and cement. Note: On production string a fluid caliper will be run and will figure cement with 25% excess, attempt to circulate.
