4. Perform 4 stage SPA acid job using 2100 gal 15% HCL (PAD) acid @ 2 BPM & 1300 PSI.
5. Swab 100 bbl fluid from well.
6. Pump scale squeeze 200 gal 6490 mixed in 100 bbl fresh water. Flush w/500 bbl fresh water.
7. Run back in hole w/ESP equipment on 125 jts of 2-7/8" tbg. Intake set @3869'.
