**Casing/Cement Program: Additional Comments**

COG proposes to drill a 17-1/2" hole to 300' w/fr wtr mud system, wt 8.5, vis 28, set 13-3/8" casing & cement to surface. Drill a 11" hole to 850' w/fr mud system, wt 10, vis 30. Set 8-5/8" casing & cement to surface. Drill 7-7/8" hole to 5600' w/cut brine mud system, wt 8.7, vis 29-32. Test Yeso formation. Run 5-1/2" casing & cement to surface. Note: On production string, a caliper will be run, COG will attempt to circulate cement.
