Casing/Cement Program: Additional Comments

COG proposes to drill an 11" hole to 1200' w/fresh water, run 8-5/8" 32# J-55 and cement to surface. Drill a 7-7/8" hole (and pilot hole) to 4650' and run logs. After evaluation, plug back pilot hole to 2300' with 1000 sacks of cement. Drill out to 2804' MD and kick off and drill curve to 3326' TVD 3632' MD. Drill a 7-7/8" lateral to new BHL @ 3251' TVD 7893' MD. Run a 5 1/2" 17# L-80 casing to TD cement to surface with 800 sacks.


