Drill pilot hole to 8250' and log. Set OH whipstock w/ 1120' of 2 7/8" tbg and pump 30 bbls Mudpush at 12 ppg, followed by 530sx of Class H cement, dispersant 0.080 gals/sk, retarder 0.045 gals/sk at 17.5 ppg, 0.94 cu ft/sk and 0% excess from pilot hole TD to KOP. KO lateral drill through the curve to TD. Run 5 1/2" casing to TD and cement.

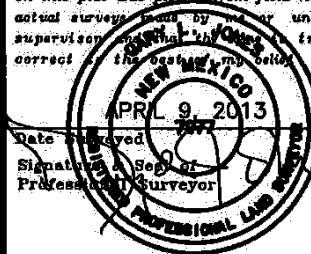
