Casing/Cement Program: Additional Comments

Drill 17-1/2" hole to ~300' w/ fresh water spud mud. Run 13-3/8" 48# H40 STC casing to TD and cement to surface in one stage. Will use 1" tubing and Class C w/ 2% CaCl2 to cement to surface, if necessary. Drill 12-1/4" hole to ~2320' with saturated brine water. Run 9-5/8" 36# J55 LTC casing to TD and cement to surface in one stage. Drill 7-7/8" vertical hole, curve and lateral to 12384' with cut brine. Run 5-1/2" 17# P110 LTC casing to TD and cement in one stage bringing TOC to 2020' (300' overlap).

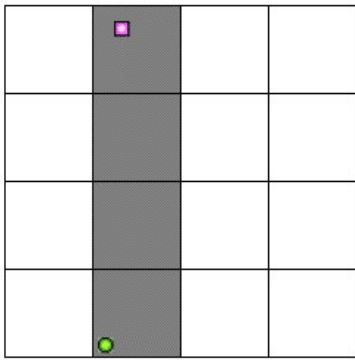
