Plan to drill a 17-1/2" hole to 1800' with Fresh Water. Run 13-3/8", 54.5#, J-55 csg and cmt to surface. Drill 12-1/4" hole to 3400' with Brine, and run 9-5/8", 36#, J55 csg and cement to surface. Drill 7-7/8" pilot hole to 10,600'. Plug back pilot hole with cmt. Drill 7-7/8" curve and lateral with cut brine to approx 14,835'MD. Run 5-1/2", 17#, P-110 csg and cement to 2850' in 1 stage.

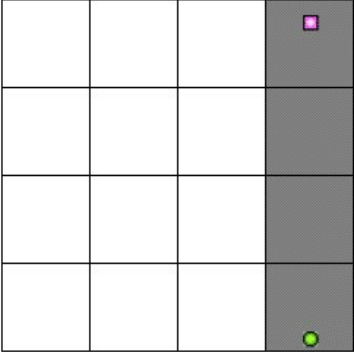
