Attached is a plat outlining the existing Third Delaware Participating Area (Exhibit "A") and the requested Fourth Delaware Participating Area along with a schedule (Exhibit "B") showing the lands to be included within the Participating Area along with corresponding tracts, lease numbers, participating areas and percentage of participation.

The attached geological mapping and the production data indicate there are commercial reserves being produced outside of the current Nash Delaware Participating Area. As described in the 2013 Plan of Development, All three wells, Nash #50H, Nash #51H, and Nash #58H, were planned to reach TD outside the PA. All of the wells reached their permitted TD and all three wells reported excellent oil and gas shows at TD. The completed interval in each well was either partially or entirely outside of the current PA.

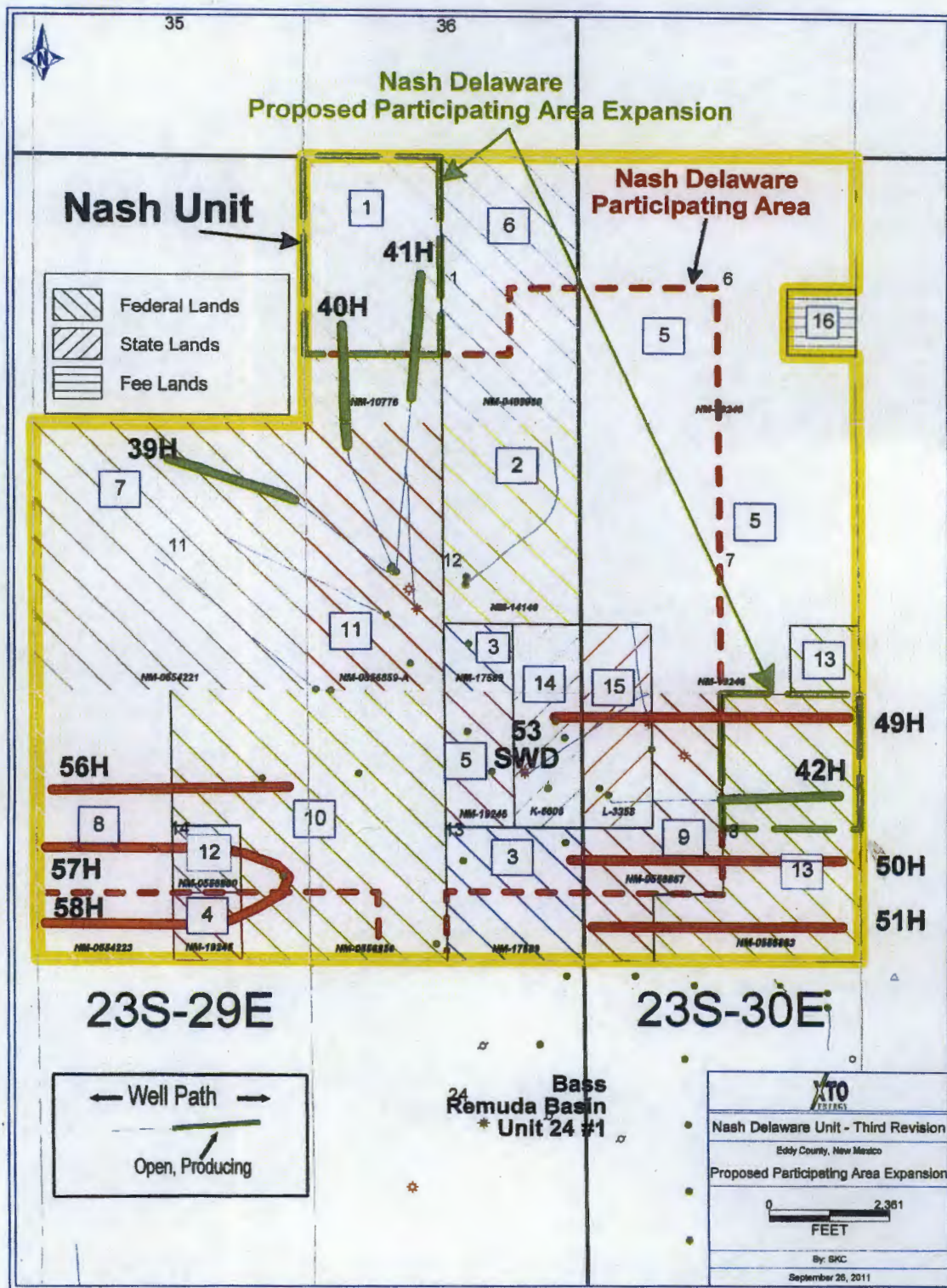
