Drill 8-3/4" to 9700' to kick off and drill curve and lateral with cut brine to approx 14,700' MD. Run 5-1/2" 17# LTC P-110 csg and cement to 4500' in 1 stage.

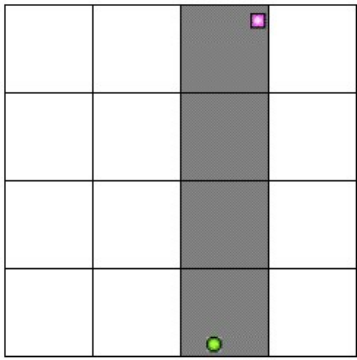
