Drill 17-1/2" hole to ~ (+/-) 1840' w/ fresh water spud mud. Run 13-3/8" 54.5# J55 STC casing to TD and cement to surface in one stage. Will use 1" tubing and Class C w/ 2% CaCl2 to cement to surface, if necessary. Drill 12-1/4" hole to ~ (+/-) 3550' with saturated brine water. Run 9-5/8" 36# J55 LTC casing to TD and cement to surface in one stage. Drill 8-3/4" vertical hole, curve, and lateral to ~ (+/-) 15009' with cut brine. Run 5-1/2" 17# HCP110 LTC casing to TD and cement to surface in one stage.
