Drill out 8.75" intermediate, kick off and drill an 8.75" curve and lateral to 13938' with cut brine. Run 5-1/2" 17# P110 production string and cement to 2400'.

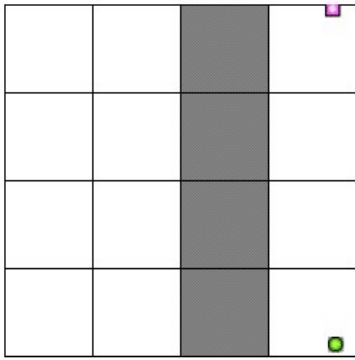
