MIRU. Spud 10/7/2019. Drill 17.5" hole to 470'. Run 13 5/8" csg, 54.5#, 12 jts, J55, STC, to 470'. 10/8 - Cement csg with 20 bbls spacer, 535 sacks of tail cement with 293 sacks of cement to surface. RDMO. 12/7 - MIRU. NU BOP, pressure test annualr (250/3500), all others (250/5000). Pressure test csg to 1500 for 30 min, held, test good. Drill 12-1/4" hole to 2716'. Run 9 5/8" csg. Cement csg by pumping 20 bbls of spacer, 760 sks of lead cement, 175 sks of tail cement with 447 sks of cement to surface. 12/10 - Pressure test csg to 2100 psi for 30 min, 5 psi drop. Test good. Drill 8 3/4" hole to 15836' (TD).
