RIH w/ 13-3/8" surface casing as follows; float shoe, 1 joint of casing, float collar followed by 31 joints of 13-3/8", 54.5 lb/ft, j-55 casing, btc thread to 1,308' (kb) 1,300' (gl). centralized joint 1, 3 & every 3rd joint to surface. Cemented 13-3/8" casing as follows; pre-flushed lines with water, tested lines to 4,000psi, mixed & pumped 40 bbls fresh water spacer with dye followed by 40 bbls mud push @ 12 ppg, followed by 250 bbls lead @ 13.5 ppg (812 sks), followed by	10/23/2020
