10/21/2020: Drill 12.25 inch first intermediate hole to 5335 ft.

10/23/2020: Run 9.625 inch 40 lb J55 first intermediate casing to 5313 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1192 sks of 13.5 ppg lead cmt, 420 sks of 14.8 ppg tail cmt. Drop plug and displace with 400 bbls of freshwater. 110 bbls of cmt returned back to surface. Test casing to 2100 PSI for 30 minutes, good test.

10/24/2020: Drill 8.75 inch second intermediate hole to 11800 ft.

10/27/2020: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11698 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 429 sks of 11.5 ppg lead cmt, 127 sks of 13.2 ppg tail cmt. Drop plug and displace with 535 bbls of cut brine. 0 bbls of cmt returned to surface. Est TOC at 4000 ft. Test casing to 2600 PSI for 30 minutes, good test.
