10/31/2020: Slide drill to 5229 ft. Continue drilling 8.75 inch second intermediate sidetrack hole to 11375 ft.

11/3/2020: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11357 ft. Pump 20 bbls chem wash, 20 bbls vis water, followed by 464 sks of 11.5 ppg, 98 sks of 13.2 ppg tail cmt. Drop plug and displace with 519 bbls cut brine. Est TOC at 2400 ft. Test casing to 2550 for 30 minutes, good test.

Second Intermediate Sidetrack Casing Details: Casing ran: 11/3/2020, Fluid Type Cut Brine, Hole 8.75 inch, Csg Size 7.625 inch, Weight 29.7 lbs, Grade P-110, Est TOC 2400 ft, Depth set 11357 ft, Cement 562 sacks, Yield 1.35, Class H, Pressure Held 2550 psi, Pres Drop 0.
