11/5/2020: Spud well. Drill 17.5 inch surface hole to 1030 ft.

Run 13.375 inch 54.5 lb J55 surface casing to 1019 ft. Pump 20 bbls plexifiber spacer, 20 bbls CTB 15 spacer, followed by 460 sks of 13.5 ppg lead cmt, 500 sks of 14.8 ppg tail cmt. Drop plug and displace with 147 bbls of brine. 100 bbls of cmt returned to surface. Pressure test casing to 1500 psi for 30 minutes, good test.

Surface Casing Details: Casing ran: 11/5/2020, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1019 ft, Cement 960 sacks, Yield 1.34, Class C, Pressure Held 1500 psi, Pres Drop 0.
