11/14/2020: Drill 12.25 inch first intermediate hole to 5346 ft.

11/16/2020: Run 9.625 inch 40 lb J55 first intermediate casing to 5326 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1189 sks of 13.5 ppg lead cmt, 420 sks of 14.8 ppg tail cmt. Drop plug and displace with 400 bbls of freshwater. 72 bbls of cmt returned back to surface. Pressure test casing to 1500 psi for 30 minutes, good test.

11/17/2020: Drill 8.75 inch second intermediate hole to 11647 ft.

11/20/2020: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11628 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 464 sks of 11.5 ppg lead, 98 sks of 13.2 ppg tail cmt. Drop plug and displace with 532 bbls of cut brine. CemNET pumped in first 100 bbls of lead cmt. Trace amounts of CemNET returned to surface. Est TOC at 3700 ft. Pressure test casing to 2560 psi for 30 minutes, good test.
