Actual Procedure: Well spud on 12/30/2020 at 15:15 12/30/2020: Drill 17.5 inch surface hole to 1022 ft. 12/31/2020: Run 13.375 inch 54.5 lb J55 surface casing to 1011 ft. Pump 40 bbls gel with CTB-15, followed by 605 sks of 13.5 ppg lead cmt, 540 sks of 14.8 ppg tail cmt. Drop plug and displace with 149 bbls of freshwater. 0 bbls of cement returned back to surface. Ran top out job - pump 80 bbls of cmt. 5 bbls returned to surface. Surface casing not tested due to leaking cement head, will test before drilling intermediate section.
