**Actual Procedure:** Well spud on 1/17/2021 at 14:00 1/17/2021: Drill 17.5 inch surface hole to 1030 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1016 ft. Pump 40 bbls gel with CTB-15, followed by 605 sks of 13.5 ppg lead cmt, 550 sks of 14.8 ppg tail cmt. Drop plug and displace with 150 bbls of freshwater. 120 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 1/17/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1016 ft, Cement 1155 sacks, Yield 1.34, Class C.
