Actual Procedure: Well spud on 1/15/2021 at 10:00 1/15/2021: Drill 17.5 inch surface hole to 1060 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1049 ft. Pump 40 bbls gel with CTB-15, followed by 605 sks of 13.5 ppg lead cmt, 550 sks of 14.8 ppg tail cmt. Drop plug and displace with 150 bbls of freshwater. 185 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
