Run 13.375 inch 54.5 lb J55 surface casing to 1098 ft. Pump 40 bbls gel spacer, followed by 485 sks of 13.5 ppg lead cmt, 555 sks of 14.8 ppg tail cmt. Drop plug and displace with 160 bbls WBM. 180 bbls of cement back to surface. Attempt to test casing failed due to leak at cement head, will rerun test before intermediate drilled.
