Actual Procedure: 2/12/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5315 ft. 2/14/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5300 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 1160 sks of 13.5 ppg lead cmt, 443 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls of freshwater. 140 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 2/16/2021: Drill 8.75 inch second intermediate hole to 11663 ft. 2/20/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11550 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 441 sks of 11.5 lead cmt, 129 sks of 13.2 ppg tail cmt. Drop plug and displace with 528 bbls of cut brine. 5 bbls of cement returned to surface. Pressure test casing to 2550 for 30 minutes, good test.
