Actual Procedure: 2/8/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5313 ft. 2/9/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5293 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 1186 sks of 13.5 ppg lead cmt, 404 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls of freshwater. 5 bbls of spacer returned to surface. Est TOC at 2240 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 2/15/2021: Attempt to run remedial job on 9.625 inch casing. BLM approval to continue with normal operations. Test BOPS. Drill 8.75 inch second intermediate hole to 11730 ft. 2/19/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11643 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 535 sks of 11.0 lead cmt, 136 sks of 13.2 ppg tail cmt. Drop plug and displace with 532 bbls of cut brine. 70 bbls of cement returned to surface. Pressure test casing to 2550 for 30 minutes, good test.
