Pump 40 bbls gel with CTB-15, followed by 525 sks of 14.8 ppg lead cmt. Drop plug and displace with 50 bbls of brine. 59 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
