Hilcorp Energy has finished the 30-day flow test on the subject well. During the flow test, oil was produced through the intermediate valve from the Farmington sand based on a 150' section of uncemented casing below the 7" csg shoe. The producing Mesaverde was shut-in during the flow test. The intermediate valve has been shut-in and is currently producing as a Mesaverde only.
