3/12/21 - MIRU and NU BOP. Set a CIBP at 8438'. Displaced well with 90 bbls brine mud gel. Attempted to test 5-1/2" casing, failed. Spotted 50 sx Class "H" cement on top of CIBP to 8071'. Received verbal from Gilbert Cordero with NMOCD-Artesia to combine plugs 1 and 2, top of CIBP and Atoka top.
 3/15/21-3/16/21 - Tagged TOC at 8009'. Tested 5-1/2" casing from 6113'-8009', tested good.
 3/17/21 - Tested 5-1/2" casing at 5083', tested good. Tested casing from 4439'-5019', failed. Hole in casing isolated between 5019'-5083'. Received permission from Gilbert Cordero with NMOCD-Artesia to combine Wolfcamp and hole in 5-1/2" casing in a single plug. Spotted a 25 sx Class "H" cement plug from 8077'-7844' approximate TOC. Spotted a 25 sx Class "H" cement plug from 7433'-7186'. Spotted a 25 sx Class "C" cement plug from 6339'-6092' approximate TOC. Squeezed 50 sx Class "C" cement from 5083'-4925', tagged.
 3/18/21 - Tested to 500 psi, good. Perforated at 3866'. Spotted a 40 sx Class "C" cement plug from 3866'-3728' Approximate TOC. Tagged TOC at 3700'. Perforated at 1847'. Spotted a 35 sx Class "C" cement plug from 1847'-1705', tagged.
 3/19/21 - Perforated at 1150'. Squeezed 35 sx Class "C" cement from 1150'-899', tagged. Perforated at 495'. Squeezed with 35 sx Class "C" cement plug from 495'-350, tagged. Perforated at 100'. Squeezed 30 sx Class "C" cement from 100' up to surface.
 3/23/21 - Dug up cellar and cut off wellhead. Installed dry hole marker as per NMOCD. Covered cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
