Actual Procedure: 3/18/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 3164 ft. 3/20/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3152 ft. Pump 20 bbls chem water, 20 bbls visc water, followed by 648 sks of 13.5 ppg lead cmt, 604 sks of 14.8 ppg tail cmt. Drop plug and displace with 236 bbls of freshwater. 138 bbls of cement returned to surface. Pressure test casing to 1550 PSI for 30 minutes, good test. 3/21/2021: Drill 8.75 inch second intermediate hole to 10280 ft. 3/23/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 10262 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 632 sks of 11.5 lead cmt, 152 sks of 13.2 ppg tail cmt. Drop plug and displace with 469 bbls of freshwater. 30 bbls of cement returned to surface. Pressure test casing to 2600 for 30 minutes, good test.
