Actual Procedure: Well spud on 4/1/2021 at 9:00 4/1/2021: Drill 17.5 inch surface hole to 695 ft. Run 13.375 inch 54.5 lb J55 surface casing to 680 ft. Pump 40 bbls gel spacer, followed by 320 sks of 13.5 ppg lead cmt, 575 sks of 14.8 ppg tail cmt. Drop plug and displace with 98 bbls of brine. 80 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
