Actual Procedure: Well spud on 4/2/2021 at 14:00 4/2/2021: Drill 17.5 inch surface hole to 700 ft. Run 13.375 inch 54.5 lb J55 surface casing to 675 ft. Pump 40 bbls gel with CTB-15, followed by 320 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 98 bbls of brine. 87 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 4/3/2021: Drill 12.25 inch first intermediate hole to 5241 ft. 4/4/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5194 ft. Pump 20 bbls chem water, 20 bbls gel spacer, followed by 1125 sks of 12.8 ppg lead cmt, 415 sks of 14.8 ppg tail cmt. Drop plug and displace with 391 bbls of freshwater. EST TOC at 1034 ft. Pressure test casing to 2500 PSI for 30 minutes, good test. Performed top out job to get cement to surface: 886 sks of 14.8 ppg cmt – cement to surface. Surface Casing Details: Casing ran: 4/2/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 675 ft, Cement 660 sacks, Yield 1.34, Class C. Pressure test: 1500 PSI, Pressure Drop: 0.
