Actual Procedure: 4/14/2021: Test BOPS. Drill 12.25 inch first intermediate hole to 5263 ft. 4/16/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5248 ft. Pump 20 bbls chem wash, 20 bbls gel water spacer, followed by 984 sks of 11.0 ppg lead cmt, 347 sks of 14.8 ppg tail cmt. Drop plug and displace with 395 bbls of freshwater. 130 bbls of cement returned to surface. Pressure test casing to 1514 PSI for 30 minutes, good test. 4/17/2021: Drill 8.75 inch second intermediate hole to 11401 ft. 4/20/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11301 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 442 sks of 11.5 lead cmt, 117 sks of 13.2 ppg tail cmt. Drop plug and displace with 517 bbls of cut brine. 20 bbls of spacer returned to surface. Est TOC at 1000 ft. Pressure test casing to 2487 for 30 minutes, good test.
