Parted tubing @ 6268', fish in hole. 2/1/21 RU wireline, fishing tools. Attempt to retrieve fish. TOF @ 7363', pushed to 7401'. 2/2/21 RIH and retrieved 18' of fish. TOF @ 7416'. Attempt to RIH and retrieve fish. No success. RIH with camera, pump 50 bbls fresh water. RIH for second camera run. Tagged trash @ 7100', obstructed camera lens view. POOH. 2/3/21 RIH with clean camera. TOF corroded tubing with no cable on top. POOH with camera. Attempt to RIH and pull fish, retrieved 10' of fish and same cable. RIH with overshot and attempt to POOH with fish, tagged TOF @ 7457'. POOH. 2/4/21 RIH and attempt to clean out to TOF @ 7475'. Recovered 10' cable. Pumped 45 bbls hot oil. RIH and tag TOF @ 7475'..
