3/31/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 9 bbls and pressured up to 1500 psi. Set a CIBP at 2342'. Displaced well with 37.9 bbls brine mud gel. Tested 5-1/2" casing to 500 psi, good. Spotted 35 sx Class "C" cement on top of CIBP.
 4/1/21 – Tagged TOC 1742'. Perforated at 1035'. Attempted to establish rate through perf, tested ok. Spotted 40 sx Class "C" cement at 1087'. Tagged TOC 528'. Perforated at 370'. Attempted to establish rate through perf, tested ok. Spotted 30 sx Class "C" cement from 448' up to surface.
 4/21/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
