4/5/21 – MIRU and NU BOP. Dropped 1.25" ceramic ball. Pumped 8-1/2 bbls and pressured up to 1500 psi. Set a CIBP at 2283'. Displaced well with 40 bbls brine mud gel. Tested 4-1/2" casing to 500 psi, good. Spotted 30 sx Class "C" on top of CIBP.
 4/6/21 – Tagged TOC 1791'. Perforated at 1032'. Tested to 500 psi, good. Spotted 40 sx Class "C" cement at 1088'. WOC. Tagged TOC 501'. Perforated at 408'. Tested casing to 500 psi, good. Spotted a 35 sx Class "C" cement plug from 408' up to surface.
 4/21/21 - Cut off wellhead. Installed dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
