4/5/21 - MIRU and NU BOP. POOH with tubing. Set a CIBP at 2389 ft. Displaced 4-1/2 inch casing with 38 bbls brine mud gel. Spotted 50 sx Class C cement on top of CIBP to 1720', tagged. Cementing witnessed by Bob Hoskinson BLM-Carlsbad. Perforated at 989 ft. Attempted to establish rate through perf. Tested to 500 psi. Spotted a 40 sx Class C cement plug from 1039 ft – 499 ft, tagged.

4/6/21 – Perforated at 411 ft. Spotted a 45 sx Class C cement plug from 486 ft up to surface. Cementing witnessed by Bob Hoskinson BLM-Carlsbad.

4/8/21 - Cut off wellhead. Installed dry hole marker as per BLM. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
