Spoke with Steven @ 7:11 pm on 8/5/19 ****** 08/7/19 10-3/4", 40.5#, J-55 @ 923' & cmt'd w/620 sxs. TOC @ Surface. Circ to surface Pressure tested to 1500# for 30 minutes - good test. ****** Contacted BLM w/intent to run and cement surface casing Red Hills 403H. Spoke with Pat McKelvey @ 8:00 am on 8/6/19 ****** Contacted BLM w/intent to nipple up and test BOPE on Red Hills 403H. Spoke with Pat McKelvey @ 7:00 pm on 8/6/19 ***** 8/13/19 7-5/8", 29.7#, HCP-110 @ 11,468 ' & cmt'd w/1025sxs. Dv tool on jt #140 (Csg set depth 11,468')(Plug back depth 11,420')(Dv set depth 5,225'). Dropping DV tool opening plug & wait 35 minutes to fall, open w/ 750 psi, circulate 20 bbls w/ cmt truck, switch to rig pump & circulate @ 6.5 bpm (65 spm), got 40 bbls of spacer & 100 bbls cement back on BU. (start circulating @ 01:20 hrs). (will circulate thru DV tool for 5-1/2 hrs before pumping 2nd stage cmt job). 8/15/19 Pump 2nd stage cement:Test Lines to 5000 psi., Pump rate 6 bpm: 40bbls gel water spacer w/ red dye, Lead 925 sks (449 bbls) of NeoCem PL2 lead at 11 ppg, 2.73 cu ft/sk yld 16.89 gal per sack mix water, Tail 100 sks (24 bbls) of HalCem H tail at 14.8 ppg 1.33 yld and 6.42 gal per sack mix water.
