- 3. Top off the 9-5/8" surface casing with packer fluid at least 24 hours before the pressure test.
- 6. Call out chart recorder.
- 7. RU chart recorder to chart pressure test as follows:
 - Top off with packer fluid, if needed
 - Record pressure on 1 hour chart with 560 psig for 30 minutes with a 1000-pound spring
 - · Contact engineer with results of pressure test
- 8. Bleed off pressure. Complete high discharge kill test and chart bleed off on the test.
- 9. Release chart recorder.
