Catena is requesting to leave the subject well TA'd until the end of year as they evaluate the wellbore to either be converted into a disposal well or returned to production based on preliminary results from the South Vacuum Unit 35-4 well, which showed production greater than 25 bopd, this is considerably higher than expected. With this new data, Catena is re-evaluating the value of these South Vacuum Unit wells.

Catena will either PA, RTP, or convert to a disposal well prior to 12/31/2021, procedures will be submitted to the commission prior to any work commencing.
