Full returns throughout job, circ 3 sxs to surface. 5/7/2021 test 9-5/8" csg to 1500# for 30 minutes, good test. Drill 8-3/4" hole to 4805'V/10453'M – TD reached on 5/13/2021. 5/4/2021 RIH & set 7" 32# L-80 BK-HT csg @ 5126' then crossover and set 5-1/2" 20# L-80 BK-HT csg @ 10450', pump 58bbl FWS, then cmt w/ 475 sxs class C w/ additives 10.8ppg 3.15 yield followed by tail job w/ 1035 sxs class C w/ additives 13.0ppg and 1.66 yield.
