**Actual Procedure:** 7/10/2021: Drill 17.5 inch surface hole to 1140 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1127 ft. Pump 40 bbls gel spacer, followed by 665 sks of 13.5 ppg lead cmt, 340 sks of 14.8 ppg tail cmt. Drop plug and displace with 164 bbls of freshwater. 125 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 7/10/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1127 ft, Cement 1005 sacks, Yield 1.33, Class C.
