Actual Procedure: 7/11/2021: Drill 17.5 inch surface hole to 1181 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1166 ft. Pump 40 bbls spacer, followed by 560 sks of 13.5 ppg lead cmt, 290 sks of 14.8 ppg tail cmt. Drop plug and displace with 173 bbls of freshwater. 83 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
