Actual Procedure: 7/7/2021: Drill 17.5 inch surface hole to 1144 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1129 ft. Pump 40 bbls gel and water spacer, followed by 640 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 164 bbls of freshwater. 134 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
