Actual Procedure: 6/13/2021: Drill 17.5 inch surface hole to 1126 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1111 ft. Pump 40 bbls gel with CTB-15, followed by 640 sks of 13.5 ppg lead cmt, 345 sks of 14.8 ppg tail cmt. Drop plug and displace with 166 bbls of mud. 160 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 6/14/2021: Drill 9.875 inch first intermediate hole to 9626 ft. Switch to 8.75 inch hole and drill to 12250 ft. 6/20/2021: Run 7.625 inch 29.7 lb P-110 intermediate casing to 12155 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 1132 sks of 10.5 ppg lead cmt, 157 sks of 13.2 ppg tail cmt. Drop plug and displace with 555 bbls of freshwater. 265 bbls of cement returned to surface. Pressure test casing to 2674 PSI for 30 minutes, good test.
