Per COA attached are the post MIT results, the well passed a successful MIT on 6/9/2021.

Catena Resources Operating, LLC is under new management as of January 1, 2021. Catena is requested to leave the subject well TA'd until the end of year as they evaluate the wellbore to either be converted into a disposal well or returned to production based on preliminary results from the South Vacuum Unit 35-4 well, which showed production greater than 25 bopd, this is considerably higher than expected. With this new data, Catena is re-evaluating the value of these South Vacuum Unit wells.

Catena will either PA, RTP, or convert to a disposal well prior to 12/31/2021, procedures will be submitted to the commission prior to any work commencing.

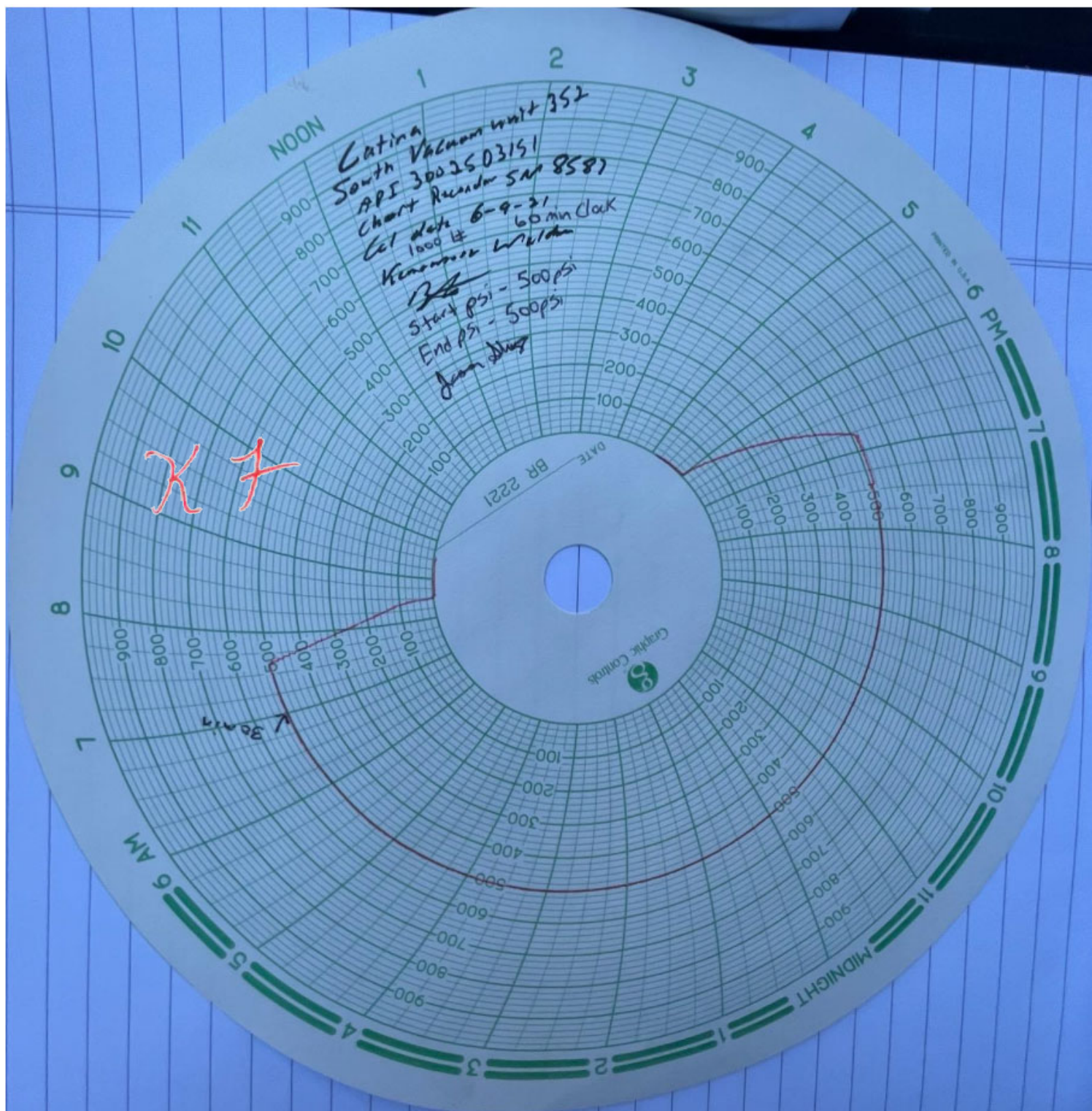

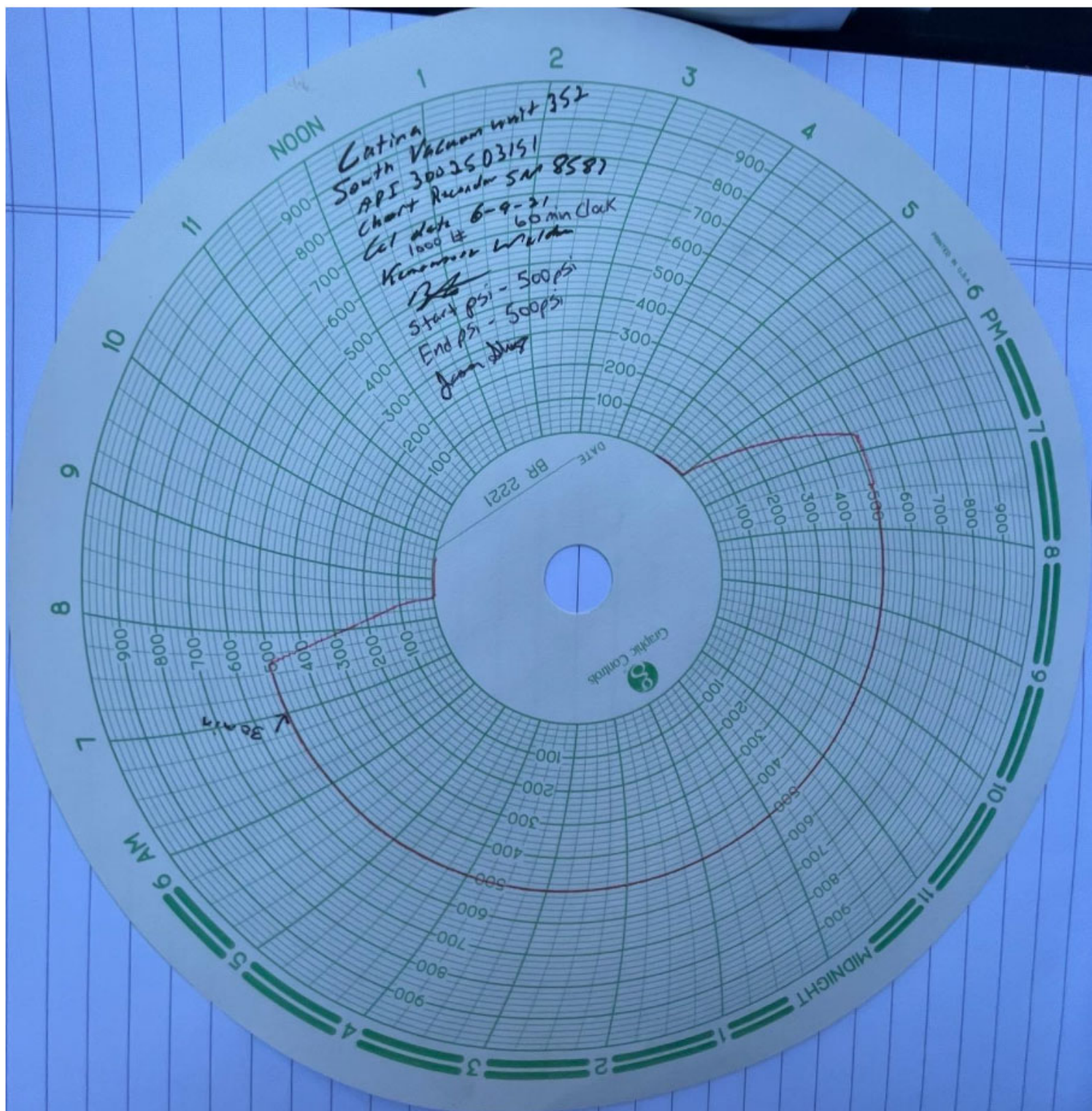
