Actual Procedure: 8/7/2021: Drill through cement and drill 12.25 inch first intermediate sidetrack hole to 3681 ft. 8/9/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 3666 ft. Pump 20 bbls chem wash, 20 bbls freshwater, followed by 789 sks of 12.8 ppg lead cmt, 451 sks of 14.8 ppg tail cmt. Drop plug and displace with 275 bbls of freshwater. 5 bbls of cement returned to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 8/10/2021: Drill 8.75 inch second intermediate hole to 10680 ft. 8/11/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 10605 ft. Pump 20 bbls mud push, followed by 669 sks of 11.5 lead cmt, 183 sks of 13.2 ppg tail cmt. Drop plug and displace with 325 bbls of cut brine. 77 bbls of cement to surface. EST TOC at 3311 ft. Pressure test casing to 2000 for 30 minutes, good test. First Intermediate Casing Details: Casing ran: 8/9/2021, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 3666 ft, Cement 1240 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
