Pump 40 bbls gel spacer, followed by 400 sks of 13.5 ppg lead cmt, 480 sks of 14.8 ppg tail cmt. Drop plug and displace with 167 bbls of brine. 117 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test.
