**Actual Procedure:** 8/4/2021: Drill 17.5 inch surface hole to 1137 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1121 ft. Pump 40 bbls gel spacer, followed by 400 sks of 13.5 ppg lead cmt, 480 sks of 14.8 ppg tail cmt. Drop plug and displace with 167 bbls of brine. 117 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. Surface Casing Details: Casing ran: 8/4/2021, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 1121 ft, Cement 880 sacks, Yield 1.33, Class C.
