**Actual Procedure:** Liner Casing & Cement / Depths have been adjusted for 25' KB of production rig 8/28/21: ad 1000 accepted on daywork. NU 11 inch 3M BOP with installed 11 inch 5M Cameron wellhead. PT 7 inch 26# J55 LTC casing 1500 psi for 30 min. Test good & recorded on chart. (3rd party Wilson Services). No regulatory agencies on site to witness. Drill 6.125 inch hole from 5605 ftKB to 5795 ftKB. 8/29/21: Drill 6.125 inch hole from 5795 ftKB to 9224 ftKB. 8/30/21: Drill 6.125 inch hole from 9224 ftKB to 10621 ftKB. 8/31/21: Drill 6.125 inch hole from 10621 ftKB to 11711 ftKB. Encountered pressure spike while performing slide. Circulate. TOH. Pump slug. Stand back non mag collars & MWD. Pull motor. Connection at bottom of bent housing came unscrewed leaving 6.125 inch bit, mandrel, transmission & rotor in hole. Total length of fish is about 25'. Due to low probability of success, decision made not to fish, call total depth of well & run liner. TIH with non mag drill collars. PU 6.125 inch bit & sub. TIH. Tagged top of fish at 11,677' TD (TVD 5308'). 9/1/21: Contacted NMOCD & BLM via email. Revise 4.5 inch liner cement as follows: Planned top at 5366'. Planned bottom at 11667' (assuming bottom of liner will be 45' above TD). 148 bbls (531 sx), Class G cement, 13.3 ppg, 1.56 yield, 40% excess. Revised cement design is attached. RU casing crew. Run 146 jts of 4.5 inch 11.6# BTC P-110 production liner set from TOL: 5353' BOL: 11672'. Float collar at 11658'. Alpha Sleeve at 11636'. Marker jts at 5635', 8669', 11454'. RU American Services cement crew. 5000 psi test on lines. Test good. Class G cement with 40% excess. 147 bbls (530 sx) 13.3 ppg, 1.56 yield, 7.70 gps. Bump plug 1887 psi, pressure up to 2909 psi & hold for 5 min. 40 bbls good cement to surface. TOC: 5353' BOC: 11672'. No regulatory agencies on site to witness. RD cementers. 9/2/21: ND BOP. Install packoff. PT to 5000 psi. Test good. Install PV & night cap. Rig AD 1000 released on 9/2/21 at 1530 hrs.
