At 6:00 P.M. 07/21/21 tested csg to 1500 PSI for 30 min, held OK. FIT to 10.0 PPG EMW. Drilled out at 8 ½". 07/25/21 TD'ed 8 ¾" hole @ 9844'. Ran 9763' of 7" 29# ICP110 LT&C csg.
