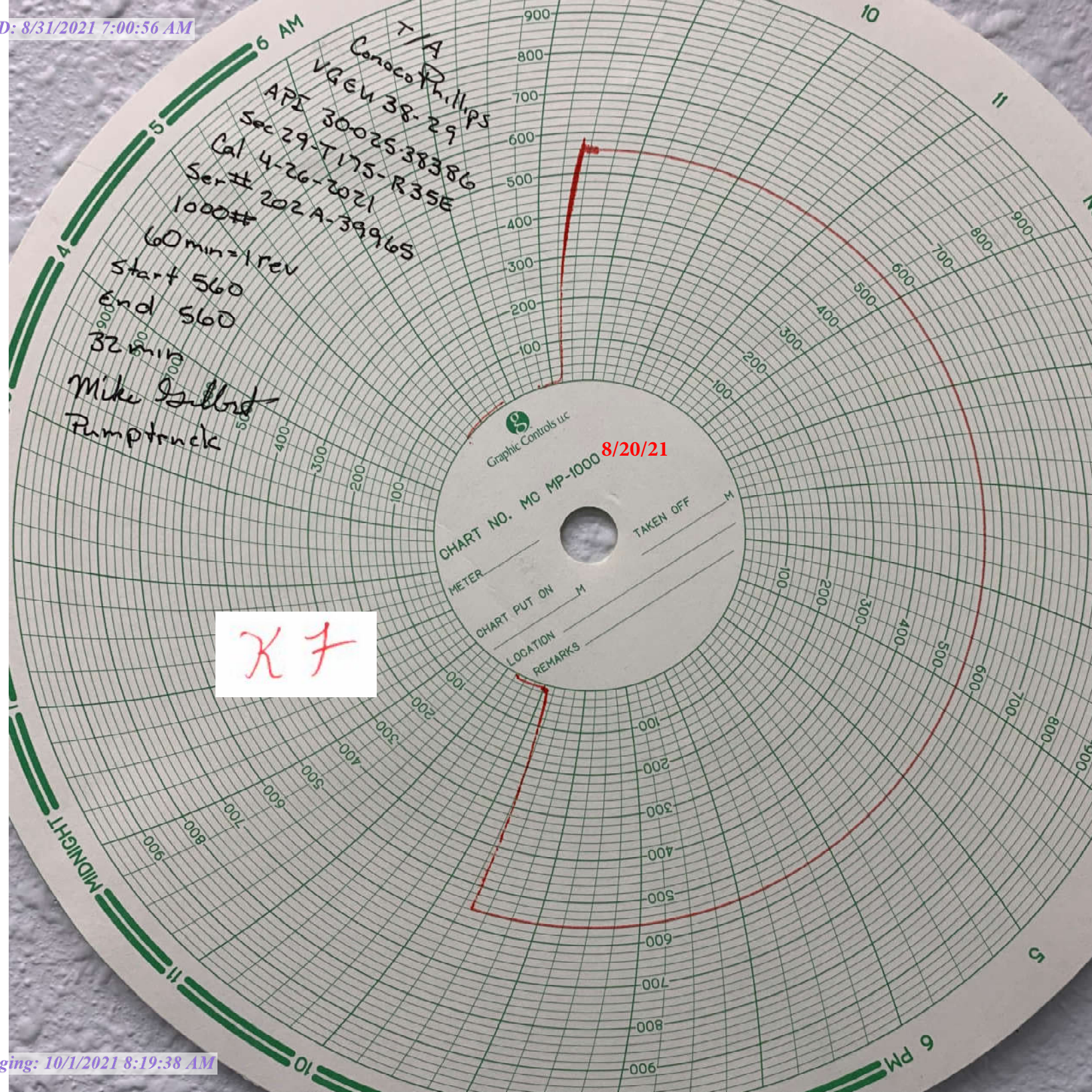

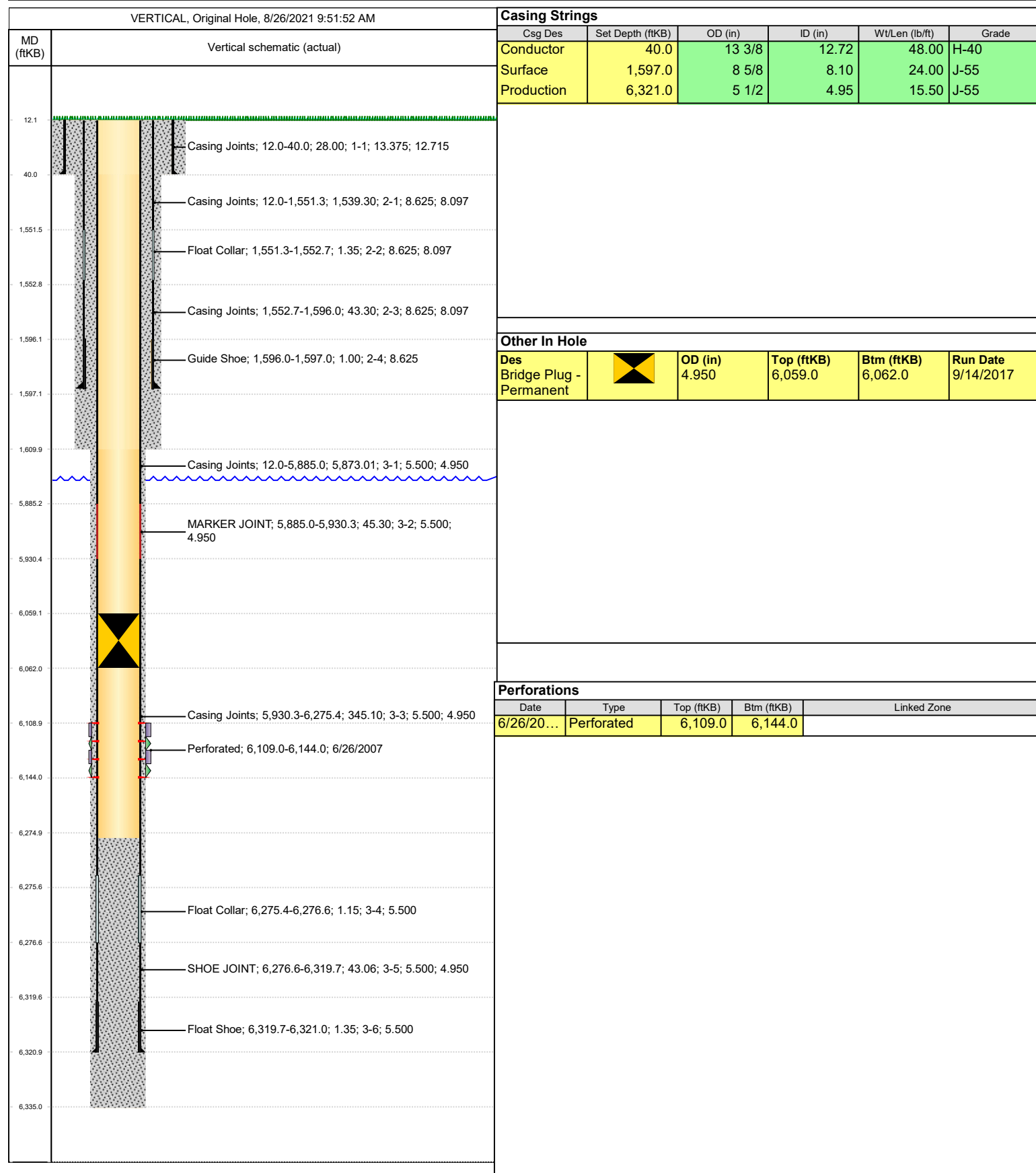

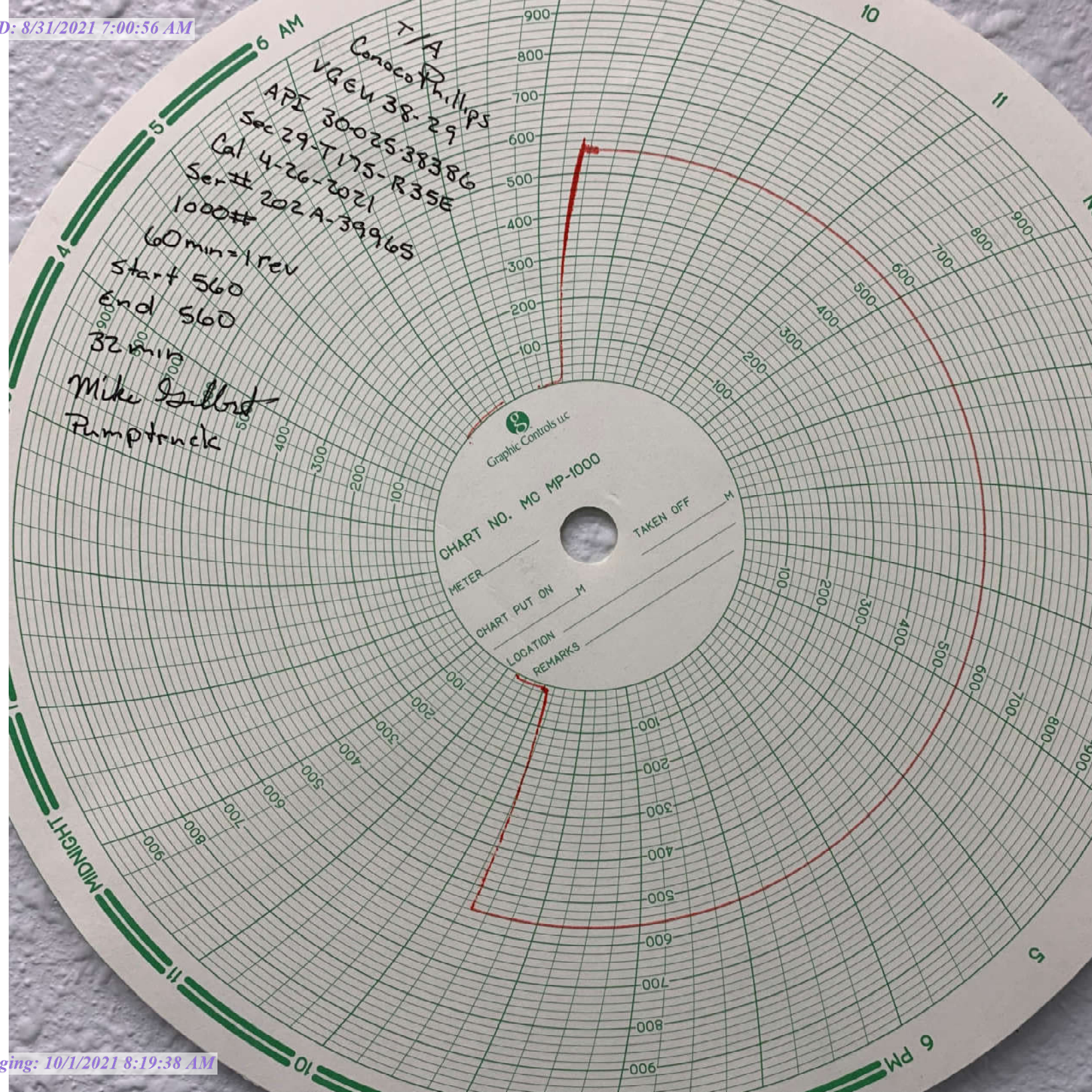


Current Schematic

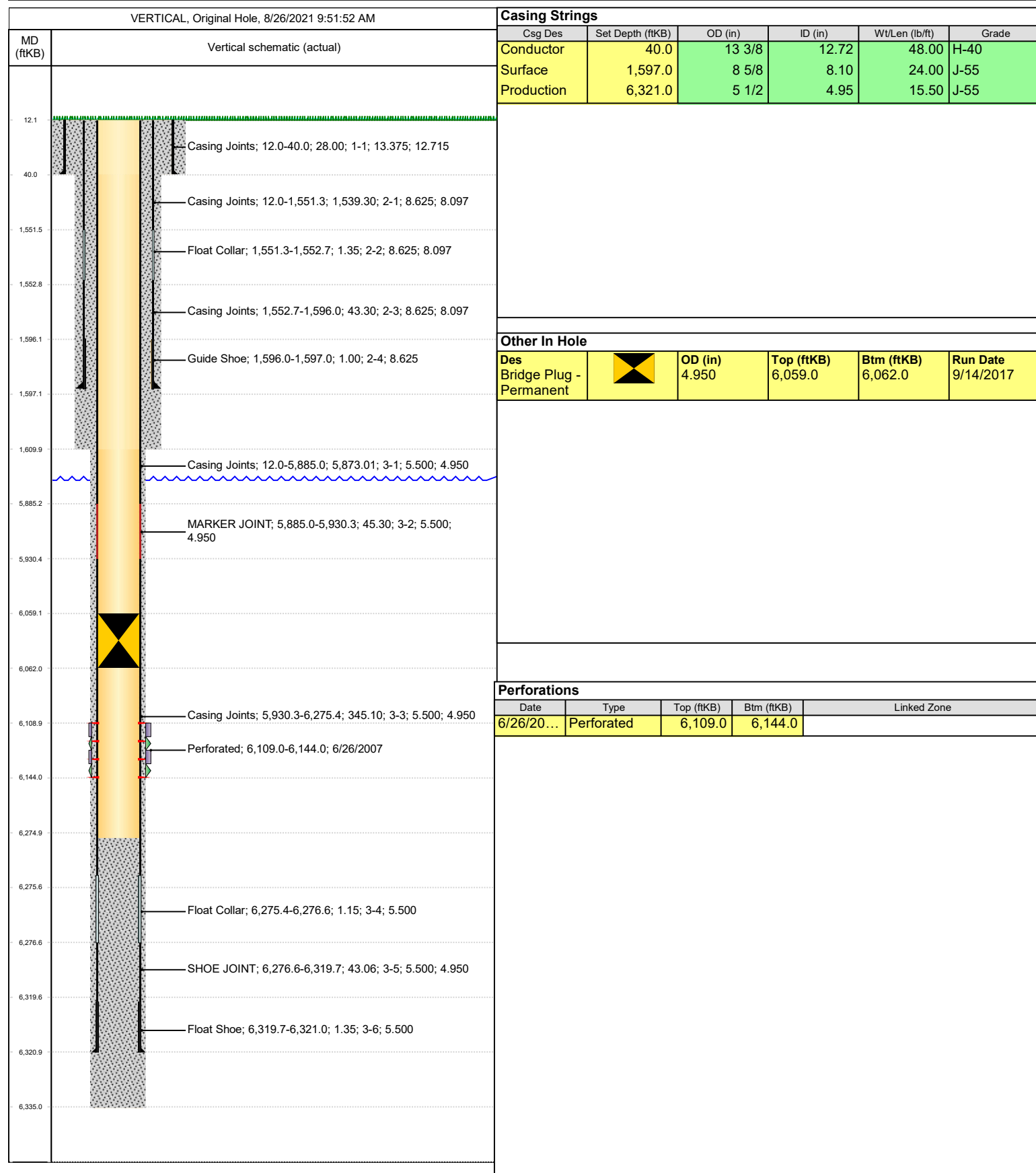
